

# German Citizenship Test (2008)

## Abstract

The federal states [Länder] offer preparatory courses for those who need to take the test. The fee to take the test is 25 Euro. Migrants who have a German high school diploma or who "are incapable of taking the test due to a physical or mental illness, disability or due to advanced age" as defined on the website of the Federal Office for Migration and Refugees are exempted from the test.
